Daily Overdraft Fee – when a negative balance is created by check, bank fee, in person or ATM withdrawal, or other electronic means applicable	<b>\$5.00</b> every business day the account is overdrawn in any amount; starting 3 business days after the account is first overdrawn.
Check Rejects	<b>\$2.00</b>
Account closed within 90 days	<b>\$25.00</b>
(*) No Overdraft Fee or Returned Item Fee is assessed if the overdrawn balance is <b>\$10.00</b> or less. Maximum amount of Overdraft Fees/Returned Item Fees charged per day is <b>\$180.00</b> . This does not include any Daily Overdraft Fee.
